Responsibilities

Coordination and Supervision

Coordinate, manage and monitor the workings of various departments in the organisation.

Financial

Review financial statements and data. Utilize financial data to improve profitability. Prepare and control operational budgets. Control inventory. Plan effective strategies for the financial wellbeing of the company.

Best Practices

Improve processes and policies in support of organisational goals. Formulate and implement departmental and organisational policies and procedures to maximize output. Monitor adherence to rules, regulations and procedures.

• Human Resources

Support the Human Resource Department in the following; the organising of recruitment and placement of required staff, establishment of organisational structures, delegation of tasks and accountabilities. Collaborate with the HR Department in establishing work schedules, supervision of staff, monitoring and evaluation of performance.

Production

Coordinate and monitor the work of various departments involved in production, warehousing, pricing and distribution of goods. Monitor performance and implement improvements. The Operations Director must seek approval from the Managing Director when hiring and firing via the Group HR department and the associated policies, this only pertains to management positions. The Managing Director must approve new positions and compensation in conjunction with the Operations Director. The Operations Director must strictly enforce Company policies and procedures applicable to the production department. To prepare job descriptions and/or duties lists for production personnel, when and where appropriate, in conjunction with the company policy, subject to final approval of the ABP Group HR Manager. Authority to enforce the Company's Safety Policies. The Operations Director must keep the Managing Director apprised of activities within the company.
